

MANDATORY NAR CODE OF ETHICS CYCLE 7 DUE BY DECEMBER 31, 2024

All members of the National Association of REALTORS® are required to take a 2.5-hour Code of Ethics class every three years.


Not sure if you have satisfied the Ethics requirement? <u>Click</u> <u>here to check your Code of Ethics status.</u> You will need to log in to NAR to check. Don't know your M1/NRDS number? You can find it on your Member/Info Hub under My Info.

If you took the Ethics class from CBRAR between January 1, 2022, and today, you have already fulfilled the requirement and the Ethics information has been reported to NAR.


RPR is free for CBRAR members and is a way to share property and market data with your clients. RPR also has a mobile app!

RPR provides free webinars, walkthroughs, and tutorials on a wide range of topics critical to your real estate business.



In this video, you'll learn the answer to, "What is Reverse Prospecting?".


You'll also learn how to view Reverse Prospecting results from a Listing Agent's perspective and then how to contact a prospective buyer's agent with information about your property.

How To Update The Firmware on a SentriLock Lockbox

- 1. Launch the SentriKey® Real Estate app.
- 2. Open The Menu in The Top Left. ...
- 3. Tap 'My Lockboxes'
- 4. Select 'Update Firmware'
- 5. Press 'ENT' on Your Lockbox. ...
- 6. Click Update Now.
- 7. Wait For The Firmware To Update. ...
- 8. The Lockbox Firmware Has Been Updates.
